# Regular Commission Meeting June 24, 2025

#### Call to Order

Director McVey abstained from Bensalem Township Police Department. Sergeant Ross and Chief Splain abstained from Eddystone Borough Police Department and Waynesboro Police Department.

#### **Premier Agency Recommendations**

The following agencies have successfully completed five or more reassessments and are eligible for Premier Status: Dallas Township Police Department, Easton City Police Department, Fairview Township Police Department, Franconia Township Police Department, Lower Salford Township Police Department, Penbrook Borough Police Department, Upper Merion Township Police Department, and Warren City Police Department. On a motion made by Chief Hettinger and seconded by Chief Ficco all agencies were granted Premier Status for their next 3-year cycle. #### **Committee Reports**

#### Assessment Committee

To help assessors, the Assessment Committee drafted definitions for the following: non-compliance, file maintenance, and applied discretion. Committee Chairman Chief Hendershot presented these definitions to the Commission.

Chief Hettinger noted that under non-compliance policy it says, "not included in the file..." The first sentence under file maintenance policy says "...not shown in the file." He thinks the first sentence on the file maintenance policy definition should be removed.

Corporal Madrak thinks that first sentence should stay, and rather the sentence under non-compliance policy should be removed. Chief Hettinger agreed with this.

Chief Hendershot advised that he will update the wording.

Chief Benson stated that this should be added to the Assessor Manual.

Coordinator Adams said that he is currently working on updates to the manual.

#### Standards Committee

Committee Chairman Corporal Madrak submitted a brief report on the meetings of the Standards Committee. A more detailed report on the standard changes will be presented at the next Commission meeting.

#### Administrative Committee

Committee Chairman Chief Hettinger had no report.
