WHY WE ARE HERE: ACT 59 OF 2020

- Amending Titles 44 (Law and Justice) and 53 (Municipalities Generally), providing for mental health evaluations and treatment for law enforcement officers exhibiting signs of PTSD and providing for powers and duties of the commission
- Signed into law July 14, 2020 Effective in one year (July 14, 2021)
- By March 14, 2021 (60 days + 6 months) Commission will promulgate regulations to establish procedures to guarantee confidentiality of requests or recommendations for mental health evaluations and confidentiality of mental health records.

- High Rates of Trauma + Stress
- Low Rates of Seeking Help

TRAGEDY UPON TRAGEDY

- Violent protests, property destruction rage against the police
- Disconnect with officer perspective causes internal conflict:
 - "Why doesn't the officer have a right to live?"
 - "We never asked to be sent to these calls so why are we being blamed?"
- Impact can be longstanding and far-reaching:
 - Family of the victim AND the officer(s)
 - Officers across the country are impacted with same conflict
 - decision making

DEFINITIONS - 44 PA. C.S. § 7202

- Administrative duty An administrative law enforcement duty that is designed to limit a law enforcement officer's day-to-day work-related interactions with the public.
- Law enforcement agency (1) A police department of a county, city, borough, incorporated town or township.
 (2) A county district attorney's office.
- Law enforcement officer An individual employed by a law enforcement agency who is required to be trained under 53 Pa.C.S. Ch. 21 Subch. D (relating to municipal police education and training).




POST-TRAUMATIC STRESS DISORDER

- 44 PA. C.S. § 7202 As defined by the American Psychiatric Association and documented in the American Psychiatric Association's Diagnostic and Statistical Manual of Mental Disorders, 5th edition.
- American Psychiatric Association A psychiatric disorder that may occur in people who have experienced or witnessed a traumatic event such as a natural disaster, a serious accident, a terrorist act, war/combat, or rape or who have been threatened with death, sexual violence or serious injury.

TRAGEDY UPON TRAGEDY

- How does any person process something as horrible as this?
- People see it in the *news*, officers *live it*
- Cumulative effect of lesser situations
- Pinning on a badge does not create an emotional shield
- Within our profession we must be cognizant of the fact we could make it worse...



INITIATION OF MENTAL HEALTH EVALUATIONS

As a <u>condition of continued employment</u>, and <u>without cost to the law</u> <u>enforcement officer</u>, a law enforcement agency <u>shall</u> provide a law enforcement officer with a mental health evaluation for post-traumatic stress disorder by a <u>licensed mental health professional</u>:

- 1) Upon request of the law enforcement officer
- 2) Upon recommendation of a police chief or other supervising law enforcement officer
- 3) Within 30 days of an incident of the use of lethal force during the course of law enforcement duties



TREATMENT

If a licensed mental health professional determines during the mental health evaluation under subsection (a) that a law enforcement officer has symptoms of post-traumatic stress disorder, the law enforcement officer shall be provided with treatment under a licensed physician's care until the licensed physician determines in writing that the law enforcement officer is able to resume full duties.



ADMINISTRATIVE DUTY

A law enforcement officer shall be assigned to administrative duty if the law enforcement officer:

1) fails to undergo a mental health evaluation for posttraumatic stress disorder when required under subsection (a); <u>or</u>

2) is experiencing symptoms of post-traumatic stress disorder as determined by a licensed mental health professional under subsection (a) and whom the licensed physician has not yet determined is able to resume full duties under subsection (b).



BARRIERS TO GETTING HELP

- 90% report cultural stigma against getting help
- 85% fear being seen as weak or unfit for duty
- 80% have not used EAP services
- 59% found services unhelpful

- Proactive and reactive
